A Seminar on Wind Turbine Noise

"Bigger is Better & Scotland's stepping stone to the future"

According to the wind energy industry¹ "**Bigger is Better**", because bigger turbines will generate more electricity and compensate financially for the recent reduction in government subsidies.

There are around 3000 wind turbines across Scotland. Inadequate government control of the distances between turbines and homes has already allowed developers to unintentionally degrade the health of many victims, and even drive families out of their homes. There is also clear scientific evidence that even bigger turbines will increase their existing sound power emissions, along with the accompanying infrasound and potential adverse health impacts on those affected. By way of example, the two very large 'test' turbines erected by Scottish and Southern Electricity at Hunterston in North Ayrshire have grossly affected the health of people living on the Isle of Cumbrae and in Fairlie, up to 3 km from the turbines. 17 people including 2 children, all complain of similar symptoms. Their GPs can do nothing to help them as their 'condition' is not recognised by public health.

Similar symptoms such as loss of balance, nausea, loss of coordination, a pressure in the ear, thumping in the head or chest, urinary and bowel incontinence, epistaxis (high volume nosebleeds) are already being reported from people living in close proximity to turbines and windfarms in other areas of Scotland, UK and elsewhere in the world. Common to all "sufferers" is that the symptoms recede when they move away from the turbines. It is believed that these symptoms are caused by the infrasound emission, which is very low frequency sound.

So, the real problem with wind turbine noise is not audible noise; it is the infrasound emission, and as yet there are neither standards nor planning guidance to deal with it.

This is already a public health catastrophe, which cannot be merely attributed to victims "disliking turbines" or any other pseudo-psychological reasons, or "non-acoustic factors", as often proposed by the wind energy industry to explain reported adverse health symptoms.

The speakers at the Glasgow Seminar are Professor Mariana Alves Pereria and Dr John Yelland, both acknowledged experts in this highly specialised field of science, which up to now has been largely ignored, to the cost of an ever-increasing number wind farm noise victims.

The Seminar will be of interest to: Anyone Living Close to Turbines, Wind Energy Developers, Public Health Protection Officials, Environmental Health Officers, General Practitioners, Councillors and Council Officers, Members of the Scottish and Westminster Parliaments, and indeed anyone seeking to understand the truth about wind turbine noise.

- 1. This seminar on wind turbine noise is to raise awareness and disseminate current, sound independent research so that those affected are taken seriously and wind turbine noise guidance is changed for the better, for all concerned. - 2. Bigger is Better according to the wind energy industry: Renewable Energy News page 14 issue 366, 13/08/2017 "Scotland's stepping stone to the future". EDF Energy Renewables is proposing to make a new application for its consented Stranoch wind farm site in Dumfries and Galloway between New Luce and Barrhill. The company was awarded planning consent for a 72MW wind farm in 2016 but it is planning on making a new Section 36 application for 'more efficient' turbines 175metres (blade to tip) with 3-4MW power output turbines.
- 3. Symptoms are caused by turbine infrasound emissions, which are pulsating changes in air pressure at rates of around one pulse per second. They cannot be heard, except by some as a clicking in the ear, but can be perceived through the symptoms already described. Turbine infrasound is well below 20Hz and therefore inaudible.
- 4. Current Government guidance does not define a fixed limit to turbine noise levels at local homes; instead, in simplified terms, turbine noise at any home must not raise the noise level there by more than 5 dB above the background noise measured there without turbines. So, the real problem with wind turbine noise is not audible noise; it is the infrasound emission, and as yet there are neither standards nor planning guidance relevant to wind turbine infrasound, or even low frequency audible sound. (or indeed any turbine acoustic emissions below 45 Hz) Neither is there any approved guidance on what the wind industry call "excessive amplitude modulation" (EAM) from wind turbines, which, in reality, is slightly more audible noise than usual, combined with a much higher level of infrasound than usual.
- 5. There are already residents in Scotland who have abandoned their homes, solely due to wind turbine noise both audible and inaudible, there are also other residents who are being severely affected, this issue needs positive and proactive responses and the seminar is an open invitation for all those who need to be informed. There will be a Q/A session at the end.
- 6. Email trail between Denise Dunn a local resident at Fairlie complaining of adverse health impacts to North Ayrshire Council on Wednesday 6th September; and responses highlighting the reality occurring immediately & every time the Hunterston wind turbine is operational (copied to NHS Ayrshire and Arran, Local MSPs, MPs and District Councillors and Melvin Grosvenor). I feel desperately sorry for the dreadful predicament you have been put in - but it is simply not the case that nobody knew their were health issues associated with wind turbines. An eminent American physicist, Dr. Neil Kelley, undertook extensive published research for NASA in 1987 on the dangers to human health of wind turbine generated infrasound. For twenty-five years thereafter there were numerous scientists and doctors all expressing the same, well documented fears. This was pointed out by Fairlie Community Council to NAC at the time of the original planning application by SSE. Needless to say all of FCC's objections at that time were dismissed out of hand by NAC's Planning and Environmental Health Officers. Unfortunately, our elected councillors on the Planning Committee opted to listen to the civil servants rather than the scientists.

It may be worth repeating here the statement made at the Fairlie Community Council meeting on Monday night (4th September 2017) which I sincerely trust will be minuted. It is not difficult to understand NAC's reluctance to include 'danger to health' as one of the formal reasons attributed to the Planning Committee's decision to refuse (as an 'opinion') SSE's application for a two year extension. Had they done so then NAC's Environmental Health Department would have had no alternative but to immediately close down the wind turbine test site on health and safety

grounds. Similarly, they would then be looking straight down the barrels of a multi-million pound, class action law suit for ever having consented the test facility in the first place.
